If you fail to notify SprinkleBrokerage as soon as practicable when any of the above conditions occur, neither SprinkleBrokerage nor any of its officers, employees, agents, affiliates or subsidiaries can or will have any responsibility or liability to you or to any other person whose claim may arise through you for any claims with respect to the handling, mishandling or loss of any order.

You further agree that SprinkleBrokerage and its affiliates will not be liable for any consequential, incidental, special, or indirect damage (including lost profits, trading losses and damages) that result from inconvenience, delay or loss of the use of the Service even if SprinkleBrokerage has been advised of the possibility of such damages.
